### **GENERAL INFORMATION**

Persons listed in this booklet have gained their qualifications by passing the high standard of courses and tests set by NAFAS.

Clubs and Societies may engage a Judge, demonstrator, Speaker or Teacher on the exchange of the official Blue Booking Form. Before sending this form, it is essential to make full enquiries by letter, e-mail or telephone regarding travel expenses, fees, cost of flowers, if hospitality is required and whether VAT is to be charged. When completed, this form constitutes a contract between the Club or Society and the Judge, Demonstrator, Speaker, or Teacher who agrees to fulfil the terms of the agreement. Members should note that only NAFAS qualified or trainee persons are covered by this contract.

An "Open Meeting" is one which is advertised, and tickets are sold to people who are not members of the Club or Society prior to the date of the event.

The information given against the names in these lists has been supplied by the persons concerned and, whilst every effort has been made to check it, the Area cannot be held responsible for any inaccuracies.

**NAFAS RECOMMENDED MILEAGE RATES**  
**As from 1<sup>st</sup> January 2022**

The NAFAS National Board have agreed to recommend a mileage allowance of 0.45p per mile as per the HMRC guidelines, should be used for claims from Judges, Demonstrators, Speaker, Adjudicators, and Instructors. Please note that if, after discussions, an agreed mileage rate in excess of 0.45p is applicable then this may well be subject to tax implications. Please visit the HMRC website for additional information. Electric cars are currently subject to the same allowance but new guidance due from HMRC is being monitored.

**COMPLAINTS PROCEDURE FOR JUDGES, DEMONSTRATORS, SPEAKERS, AND TEACHERS**

The complaints procedure may be used by Clubs against persons whose names are contained in the current South West Area List and vice-versa.

1. A letter of complaint is sent in writing to the Area Representative within two months of the event, outlining the nature of the complaint.
2. The Representative will speak to the person concerned.
3. The Representative sends a copy of the letter to the person concerned who replies by letter.
4. The complaint will then be reviewed by the Area Committee. A decision will be made on whether to uphold the complaint.

All correspondence, consulting etc. appertaining to the complaint procedure shall be strictly confidential.

Should three formal complaints be upheld over a period of three years, the person will be requested to retake an Area Test at the earliest opportunity if he or she wishes to remain on the Area List.

National Demonstrators Committee Complaints Procedure

Complaints against a National Demonstrator should be sent to the Chairman of the National Demonstrators Committee within two months of the event. It must be made in writing by the Club Chairman, Vice Chairman or Secretary. Please include telephone numbers and email addresses.

A letter of appreciation from a Club would also be welcomed by the appropriate Representative if the Club has particularly enjoyed using someone from the List.

**NAFAS CODE OF PRACTICE**

THE BLUE FORM – is helpful to both Club and Judge, Demonstrator, Speaker, and Teacher on the Area List. Please make use of it.

PROGRAMME SECRETARIES – may like to include the following information in a covering letter:

- 1) Description of venue including postcode: is it up or down stairs? Is there a lift? Etc.
- 2) Details of Hall. Is there staging, stage lighting or a sound system?
- 3) A good map of route and area of venue.
- 4) The correct details are given on the blue form

CHAIRMEN – should ensure that:

- 1) A demonstrator is made welcome, with adequate strong help to unload his/her material and light refreshments provided.
- 2) Toilet facilities are provided
- 3) Demonstrators are helped to re-load their car.
- 4) All invited guests are seen SAFELY to their cars.

DEMONSTRATORS, SPEAKERS, AND TEACHERS should:

- 1) Arrive on time
- 2) Make sure that they are ready to start at the time stated.
- 3) Thank the Chairman for the introduction.
- 4) Leave the demonstration area tidy
- 5) Thank members of the Club for their help.

**CANCELLATIONS**

These guidelines are quoted from NAFAS information for Demonstrators.

- a) Demonstrators/Clubs are obliged to fulfil engagements as per the Blue Form, but may, if unavoidable, withdraw from the commitment without obligation 6 months prior to the meeting.
- b) If, in the event of unavoidable circumstances, a cancellation is necessary within the 6 months period before the demonstration, the Demonstrator is expected to find a substitute of equal standing. Clubs may decline the substitute.
- c) If a Club cancels a demonstration at short notice, any expense incurred is the responsibility of the Club, subject to negotiation.
- d) In severe weather conditions, contact should be made between Club and demonstrator or Speaker before cancellation is agreed.
